 - i. Craguns contacted us about holding 2013 conference there
 - ii. Jessica shares cost breakdown of Craguns v. UMN Continuing Ed
 - iii. Proposing Thursday full day + Friday half day
- h. Partnering with Reading Recovery (Jen, Maren, Tonya)
 - i. Currently have 7 Reading Recovery teacher leaders in the state, and they work with 1-10 districts; would like to have opportunities for teacher leaders to get together and network
 - ii. Looking for ways to reach out to elementary teachers and build more membership in MRA with elementary teachers

Additional Discussion Points:

- Holding the 2013 conference in a northern area, could support reactivating NW council
- Talk to Craguns to see if it would be possible to offer conference rate for entire stay if folks want to continue to stay through the weekend
- Will likely lose people who cross-register for MCRR & MRA conferences

Decision(s):

1. Move forward for conference at Craguns, but will hold off on voting for a few weeks so leadership can go back to councils and see if there are concerns

4. MDE Update, Kari Ross

- a. Revisiting parts of Reading Well statute (including deadline extension possibility)
 - i. Data submission template will be available this week (grade, school, district level data only)
 - ii. Perhaps MRA could develop something to help districts build capacity with their Reading Well plans (districts are looking for support and are reaching out to vendors that are looking to make a profit on plan development; MRA could work on develop a series of symposium for where to start in the coming years)
- b. Focus next year will include Race to the Top (funds have been earmarked; one-time money that will last 5 years); NCLB waiver (lowest performing schools (Priority Schools) will be identified for intensive support, and schools with low performance in a category will be identified as Focus Schools, allocating resources appropriately to make AYP in all areas; schools making it off AYP list will be identified as Celebration Schools)
 - i. 3 Centers of Excellence will be created to support schools not making AYP including Reading, Math, Special Ed, EL, and Implementation Specialists to support instructional leadership and classroom instruction
 - 1) ND border to Lake Superior: Thief River Falls will be the fiscal agent
 - 2) Brainerd to Wheaton down to IA border to Mankato: St. Cloud
 - 3) Metro, Rochester, SE corner: Rochester

 - ii. Advice from Arrowhead, Central, SW: end up recycle leaders, trying to recruit college student teacher candidates, delicately recruit new members through events
 - iii. Suggestion (Deb): Eliminate vice-president and elect copresidents (or other co-positions)
 - iv. Send suggestions to exec board if there are other ideas
